Regulations affecting 10 stages of a business life are measured: starting a business, dealing with construction permits, employing workers, registering property, getting credit, protecting investors, paying taxes, trading across borders, enforcing contracts and closing a business. Data in Doing Business 2010 are current as of June 1, 2009. The indicators are used to analyze economic outcomes and identify what reforms have worked, where and why.
