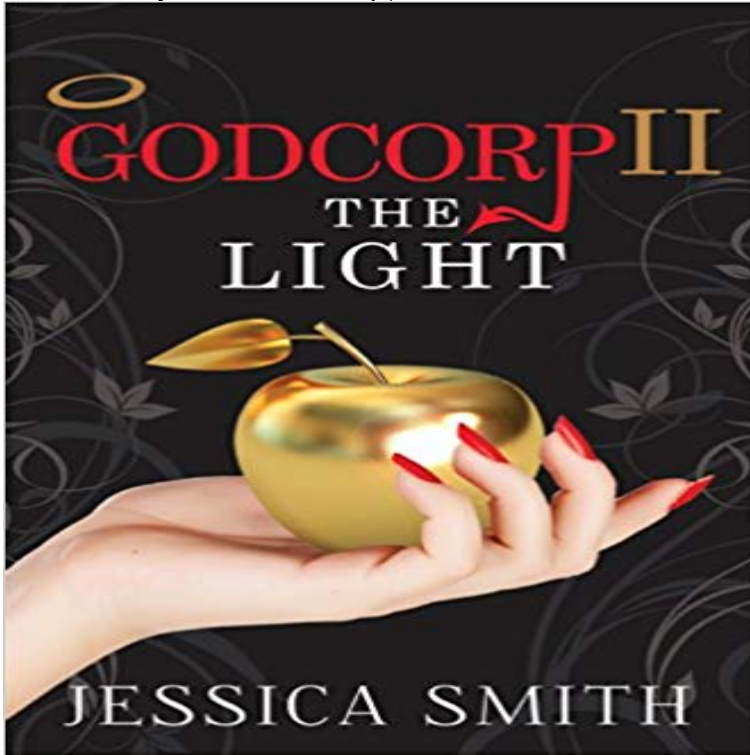


## Godcorp 2: The Light
